<p>Prince William County Public Schools Regulation 728-3 and the Standards for Accrediting Public Schools in Virginia include a provision requiring that all students in grades one through 12 shall maintain a full-day schedule of classes (5 ½ hours) unless a waiver is granted by the local superintendent of schools. For the purposes of applying this standard, any student who is not in the work release program associated with a school-sponsored career and technical education course, or in possession of an Individualized Education Plan (IEP) or Health Treatment Plan requiring an abbreviated schedule, must seek a waiver approved by the principal and the Superintendent’s designee for less than a full-day schedule. Requests will be handled on an individual basis, but generally shall be granted <u>only for health or family hardship</u> reasons.</p>
